1. Overview

The purpose of this form

- 1.1 You should complete this form if you are applying for a licence to provide a small-scale radio multiplex service (a 'small-scale radio multiplex licence'). A small-scale radio multiplex service is the means by which DAB digital radio stations ('digital sound programme services') are broadcast, and can transmit around ten stereo digital sound programme services (or a significantly higher number if the DAB+ standard is utilised). The application form is divided into two parts **Part A** (which we will publish on our website) and **Part B** (which will be kept confidential). This document constitutes Part A; <u>Part B of the application form</u> is available separately.
- 1.2 Small-scale radio multiplex licences are awarded by Ofcom in a competitive process. Applications are judged against specified criteria, and Ofcom awards the licence to the applicant which it considers best meets the criteria.

How to complete the form

- 1.3 There are detailed instructions on how to complete this form, and information on the next steps in the application process, in our <u>guidance notes</u> for licence applicants and licensees. Please read this guidance and the frequently asked questions carefully before completing this form.

Bedford Radio has been working with several community radio partners across the area to put together a strong coverage for the Bedford Borough and surrounding areas. This includes the main urban areas of Bedford town and Kempston town, as well as the rural area and villages of the borough and area including Harrold, Bromham, Turvey, Oakley and Wixhams.

We have included a slight out of polygon coverage for the St Neots area, this is after an approach and partnership with Black Cat Radio the local Community Radio Station for St Neots. The actual polygon intersects with Eaton Socon which is part of St Neots. After discussion with the local community station and their work in the area it is clear there is a strong affinity for the people of St Neots with the Bedford polygon with people travelling in the area, as well as working, shopping and visiting the area.

Consideration has been made of the existing coverage of the existing community stations (Black Cat and In2beats) and this coverage is considered to provide a good match to the existing coverage achieved by those stations in the area.

We have received interest for the full 5 C-DSP reserved capacity but are aware of other community based services in the area, so we request Ofcom to consider increasing the reserved capacity to 6 slots as we would be happy to safeguard the community position.

We have chosen to not cover the southeast area of the polygon (Biggleswade and Sandy) as the exciting community station in that area showed no interest on being on SSDAB, and that area is also covered in an overlap and named as part of another polygon.


We have chosen to not cover the far south of the polygon area (Ampthill area) as that area has little actual affinity with Bedford or the area, it's in the area of Central Bedfordshire and not Bedford Borough and from our experience and knowledge of the area know that people in that area hold if any an affinity more to the south/central area of Bedfordshire and would be better served by the Luton Polygon.

Martin Steers (Director of Bedford Digital Radio & Home Counties Community Media CIC) has been involved in radio since he was involved in studio radio in 2006, he was station manager of his student radio station CUR1350, whilst there he wrote their successful CR application which they now broadcast as Cam FM.

Since then he has worked for the BBC (BBC Oxford), commercial radio (Eagle Radio) and within the community radio sector (Diverse FM), currently holding the position of station manager of NLive Radio since September 2019

He has also held numerous RSL licenses for Scout Radio broadcasting at Jamborees and Scout events as either Scout Radio or Jam FM. During all this time he has an exemplary track record in compliance, training and in some cases the operation and management of broadcast radio stations.

In addition, he is also a Co-Founder and Director of the UK Community Radio Network CIC, and thus holds a position of responsibility for a sector based organisation.

Also, of note he is the Founder, Chair and Director of the Community Radio Awards and organisation that champions and promotes best practice within the sector.

Financial and business plan

3.17 Please provide a high-level estimate of the costs you believe will be required to establish the multiplex service.

In order to deliver our transmission network, we estimate a spend of approximately £25,000. This capital investment is required for the purchase of transmission equipment required to cover the Bedford Borough and surrounding area and deliver the proposed plan. This equipment includes the transmitter, filters, antennas, associated metal work, and installation costs. These costs have been calculated based on the real-world experience of Dean Kavanagh (Switch Radio) who is a close adviser and working with Martin Steers on a bid for Oxford. He has successfully launched the North Birmingham SSDAB multiplex and is involved in hardware purchases in preparation for launch of the Dudley and Stourbridge SSDAB multiplex.

We are proposing to use the same equipment in Bedford that are being used (and proposed to be used) in North Birmingham, Stourbridge and Dudley, and Oxford (see Part B and appendices for more detailed technical plans).

It is our proposal to utilise the Optimux multiplexing platform to manage the day-to-day operations of the multiplex. The subscriptions fees for this service will be sourced from the carriage fees charged to operators.

The majority of initial costs associated with setup of the multiplex will be met by Home Counties Community Media (see below), with additional costs covered detailed below.

A detailed business plan is submitted as Appendix 2, with projected income and expenditure for Years 1 - 3. As this plan contains commercially sensitive information, it is submitted confidentially

Martin Steers as director has extensive experience in project management professionally within radio, founding several community based organisations including Home Counties Community Media CIC, and the Community Radio Awards, and his own business Schools Radio Network, as well as a volunteer within the scouts.

Administrative management of the multiplex will be supported by use of the Optimux management platform, which simplifies a number of aspects of multiplex management as well as providing technical solutions such as cloud encoding and cloud multiplexing. This should significantly reduce the workload associated with managing the multiplex on a day-to-day basis and also allow all participants to contribute to management regardless of experience.

In addition, Bedford Digital Radio is being advised by those who have experience with DAB and SSDAB. Dean Kavanagh will act as the primary technical advisor for our application; Dean is a fellow director at UK Community Radio Network, runs the small scale multiplex North Birmingham via his role at Switch Radio, and is also a technical advisor to the Stourbridge and Dudley small scale multiplex. Switch Radio successfully operated the Trial Birmingham SSDAB multiplex between 2015 and 2022, and has recently launched the third full-time SSDAB multiplex in North Birmingham. Over the last seven years, Dean has built up significant experience in both the technical and administrative management of SSDAB multiplexes, including invoicing, service onboarding and management, monitoring, contractual agreements, and reporting. Dean Kavanagh is a director, and the lead developer, at Optimux Digital Ltd, a software company specialising in DAB multiplexing and management.

In addition and where needed, we will also work with Lawrie Hallett in an advisory capacity, Lawrie is a Senior Lecture Radio & Journalism, University of Bedfordshire (Shareholder), he has extensive knowledge and experience of broadcasting including SSDAB having successfully run the Norwich Trial since its license, and is involved still with Norwich and the successful application for North Norfolk Digital to cover the Kings Lynn area.

5. Fair and effective competition

About this section

With the support of these advisers and their contribution to the applicant body as existing operators, we have access to processes, procedures, and experience of running a SSDAB multiplex in terms of fair pricing, clear contracts, and open opportunity.

During the terms of the licence, we propose to operate a simple rate card, with costing based on the number of capacity units required. We are proposing to offer a 50% discount to C-DSP services utilising the reserved multiplex capacity. In line with the expectations of Ofcom and the legislation, we will make our rate card public well in advance of the launch of the multiplex.

If we are successful in a licence award, we intend to ensure sufficient publicity to allow for potential service providers to come forward. If we have firm and binding interest from more services than we can carry, we will select services that provide the best range of programming from the local area. We will open a public consultation to help us ensure we meet the needs of the area.

Once the multiplex is in its licence period, we will assess applications in chronological order. If capacity allows, we would expect to accept applications provided they are legitimate and possess the correct licencing and administrative documentation. However, if multiple enquiries arrive in quick succession and we are not able to accommodate them all, we may select services that better expand the range of programming available to the local area on the multiplex. We again would reserve the right to garner public opinion on how best to use the capacity and use this information to help inform our decisions.

We propose to make a clear carriage agreement and make this available for both services and the public to scrutinise upon request. The terms and conditions in this carriage agreement would apply for all services joining the multiplex at a given time, and we do not propose to create, modify, or edit these agreements for each service beyond simple elements such as names, addresses, and technical parameters. Our proposed carriage agreement, as it currently stands is included as Appendix 5 of this application.

Under no circumstances would we auction capacity, nor would we consider a willingness to 'pay more' as a factor in making a decision on carriage. We will not charge or accept carriage payments at above what is illustrated on our public rate card.
